- The first installment is due at the time of registration and thereafter on the first (1st) of every month.
- Registration fee and first month tuition installment are non-refundable.
- Yearly Tuition Discount -- Only the entire years tuition paid in full at the time of registration will receive 5% off.
- If my payment is received after the fifth (5th) day of the month I agree to pay a late fee of \$10.00.
- Accepted types of payment for tuition are personal check, money order, cash, and automatic withdrawal. No PayPal or credit cards accepted. Returned checks (NSF) will be surcharged a \$25.00 fee. If 2 checks are returned for NSF, personal checks will no longer be honored as a type of payment for preschool tuition.
- Parents are responsible for each month's tuition, regardless of absences, vacations, etc. The school's budget and teacher salaries are based upon full enrollment.
- Parents agree to participate in fundraisers to earn \$100. profit for the school or make a tax deductible donation of \$100.00 to the school.
- Two weeks' written notice must be given to school in the event a child is to be withdrawn for any reason. Parents are required to pay for those 2 weeks regardless of when the child stops attending preschool.
- Proof of current immunizations is required prior to admission.
